

3 SCOPE OF WORK

- i. Development of various modules of cyber security based on VR & AR and also provide the solution in mobile application
- ii. Each part of cyber-security module should be 3d models, proper animations and with bilingual (English and Hindi) voice overs.
- iii. There should be assessment topics covered in 2-3 modules; assessment should have interactivity and leveraging virtual reality true value. After assessment session performance results should be shared with user and saved in local file system.
- iv. There should be familiarization section for virtual reality controls at the start.
- v. Bidder should follow all procedures of Software Development Life Cycle (SDLC)
- vi. Development Plan: Bidder needs to submit development plan and storyboard within a week of allotment. In the development bidder need to provide detailed phase wise development plan.

Security Awareness Program

- a. VR & AR based Cyber Security Training Modules should be educating officials with cyber-security related knowledge and teleport them into real life scenarios in virtual reality where learning & understanding of the officials could be assessed by allowing them to take decisions or execute actions based on the lessons or skills developed.
- b. Guides Employees/students on do's and don'ts of creating their digital foot prints.
- c. It should be covering all the critical processes & procedures for providing a holistic learning & understanding to the officials regarding the various possible cyberattack and counter-measures. Additionally, the training modules should also be educating the officials about the different terminologies related to the security of any digital or internet-based payment.
- d. The experiential training modules should be covering the general practices related to cyber-security like avoiding spam email, protecting passwords & mobile device security measures. The modules should also be extensively educating the officials over the general knowledge like data types, difference between virus & malware, difference between Trojan & malware etc.
- e. The experiential training modules should also demonstrate & educate officials regarding the critical attacks like hacking, fishing by engaging them into virtual interactive experiences; redefying the consumption of technical learning.
- f. Bidder should suggest various modules to be developed for covering the above said work. After the consumption of modules, there should be tools/procedures for





comprehensive assessment of different parameters for analysing the performance & learning of individual official.

- g. To empower and protect the human being by various security threads like Privacy protection, digital payments, malware, end point security like mobile security
 - vii. **Installation:** Bidder needs to provide appropriate guidance in installing all the related hardware. Any software required in the computing device, Installation of motion sensors / Installation of HMD related/ or any other software required.
- viii. **Hardware:** -Bidder should also suggest the various hardware required for run the above said work. High end equipment as well as low end equipment etc..
- ix. All the related support technology and modules will be run on ERNET Infrastructure.
- x. Training and Handover
 - All the training materials will be provided by the bidder. Manual etc.
 - Bidder has to be provide hands-on of training
 - Bidder should provide all software codes to ERNET and it will be property of ERNET.



4 Other Terms and conditions

- i. Bidder should be able to demonstrate the working of technology deployed in India or globally if any (collaborative VR training system with multi-users).
- ii. Support and Maintenance
- iii. The bidder will ensure the availability of services from professionally qualified team during implementation of the work order and to provide the required on-site warranty/support & maintenance for one year after the acceptance tests.
- iv. The bidder shall arrange for maintenance for a period of warranty from the dates of installation of the project with regard to rectification/removal of defects if any observed during this period.
- v. The bidder shall provide comprehensive AMC of two years on per year basis after warranty period is over
- vi. Service Level Agreement
 - i. After commissioning & acceptance, during warranty & AMC, the bidder shall be responsible for minimum uptime of 98% on 24x7. The minimum uptime will be evaluated on a monthly basis for the end to end system provided by bidder. Successful bidder shall enter into this SLA upon RFP phase evaluation. The SLA shall be finalized & detailed during RFP.
- vii. Successful bidder will be fully responsible for supply of Virtual reality Based Cyber Security Modules & maintenance of related hardware.
- viii. Bidder should provide suggest Software module & Hardware module in format given in annexure 8

5. Minimum Technical Specifications

The bidders, who satisfy minimum eligibility criteria, will be considered for further evaluation based on technical specifications sought.

6. General cum Technical Bid Evaluation



7. PROPOSAL EVALUATION PROCESS

- a) ERNET INDIA will constitute an Evaluation Committee to evaluate the responses of the bidders.
- b) The Evaluation Committee constituted by ERNET INDIA shall evaluate the responses to EoI and all supporting documents and documentary evidence. The committee may seek additional documents / presentation as it seems necessary.
- c) Bidders who satisfy all the minimum eligibility criteria(s) as mentioned in section 2 will be considered for Proposal Evaluation Phase. Bidders have to submit all the relevant proof w.r.t to Section 6 General cum Technical bid evaluation and also submit the filled Annexures 6, 7 & 8 mentioned in EoI.



d. The Proposal evaluation shall include:

i. Technical evaluation of the proposals based on specifications / necessary documentations/proof provided.

The evaluation will involve validating the credentials submitted in the format as prescribed in Section 6- General cum Technical Bid Evaluation. Credentials without valid proof will be invalid and will not be considered for eligibility. ERNET reserves the right to accept or reject proof of credentials at its sole discretion without having to give reasons to the Bidders thereof. The bidders should be evaluated for shortlisting, inter-alia, based on their past experience of performance in a similar context, financial strength and technical capabilities, among others. Each bidder should be assigned scores based on sum of marks obtained for each parameter multiplied by the weightage

assigned to that parameter. All bidders who secure the minimum required marks (normally 60 (sixty) per cent) should be shortlisted.

- ii. The committee may also ask the bidders to come for Technical discussion & presentation of solutions to committee at a short notice of three days.
- iii. The committee may also ask the bidders to demonstrate the proposed solution. Bidders must be prepared for same on a notice of two days.
- iv. After the proposal evaluation by Evaluation Committee, Request for Proposal (RFP) will be issued only to successful technical qualified bidder(s).
- v. The decision of the Evaluation Committee in the evaluation of EoI responses shall be final. No further correspondence(s) will be entertained in this regard.
- vi. MSME /Start-up will be applicable as per GFR 2017 terms & conditions. Certified has to be submit along with EoI.

8. EOI PROPOSAL PREPARATION COSTS & RELATED ISSUES

The Applicant is responsible for all costs incurred in connection with participation in this process, including, but not limited to, costs incurred in preparation of proposal, PoC (Proof of Concepts) demonstration at sites, and participation in meetings / discussions. ERNET India in no case will be responsible or liable for these costs, regardless of the conduct or outcome of the EoI process.

9. EARNEST MONEY DEPOSIT

- i. Response to EoI must be accompanied by Earnest Money Deposit(EMD) of Rs. 50,000/-. which shall be in the form of Demand Draft/Pay Order/EM Fixed deposit/Bank Guarantee of any Nationalized/Scheduled commercial Bank taken in the name of ERNET India, New Delhi.
 - a. Bank Guarantee should be valid minimum for a period of 360 days from the final due date of the EoI & be submitted in compliance with the clause no. (v) of this section. The Performa for submission of BG is enclosed in this document.
 - b. In case if EoI due date is extended, Bank Guarantee should be valid minimum for a period of 360 days from the extended due late.
 - c. Response received without Earnest Money Deposit or short of value confirming to the above and /or with short period of validity are liable to be rejected.
- ii. Earnest Money is liable to be forfeited and bid is liable to be rejected, if the bidder withdraw or amends, impairs or derogates from the EoI or RFP in any respect within the period of validity of the EoI and RFP.

- iii. The EMD submitted during EoI shall remain applicable for successful and participating bidder(s) during the RFP stage and the earnest money will be returned to all the unsuccessful bidders after completion of respective evaluation phases i.e. EoI and RFP.
- iv. EMD submitted in the form of fixed deposit/BG will be returned as it is. In case of EMD in the form of DD/Pay order, No interest will be payable by ERNET India on the Earnest Money Deposit.
- v. If the successful bidder fails to submit the performance bank guarantee after the RFP process as mentioned in the EOI, the EMD of the successful bidder shall be liable for forfeiture.

10. TERMS & CONDITIONS

- i. The successful bidder shall indemnify the ERNET India/End-user departments against all third-party claims of infringement of patent, trademark/copyright or industrial design rights arising from the use of the supplied items and related services or any part thereof. ERNET India/End-user department stand indemnified from any claims that the bidder's manpower may opt to have towards the discharge of their duties in the fulfilment of the purchase orders. ERNET India/End-user department also stand indemnified from any compensation arising out of accidental loss of life or injury sustained by the bidder's manpower while discharging their duty towards fulfilment of the purchase orders. The bidder shall solely responsible for any damage, loss or injury which may occur to any property or to any person by or arising out the execution of the works or temporary works or in carrying out of the contract otherwise than due to the matters referred to in this agreement hereinbefore. The bidder would ensure for observance of all labour and other laws applicable in the matter and shall indemnify and keep indemnified the ERNET INDIA/its customers against the effect of non-observance of any such laws.
- ii. After the RFP process, the successful bidder shall submit a Performance Security of 10% of the cost of the purchase order at every occasion within 15 days of the placement of

purchase order. The Performance Security may be in the form of Demand Draft/Pay Order/Bank Guarantee of any nationalized/scheduled bank. The Bank Guarantee should be valid for the minimum period of its service liability (i.e. delivery & warranty period) + 3 months in respect of individual purchase orders. In case supplier fails to deliver the items/services within delivery/ installation/warranty period, the Performance Security submitted by the firm is liable to be forfeited. Performance Security shall be released immediately after the service liability period is over. No interest will be payable by ERNET India on the Performance Security.

- iii. After the RFP process, if the selected bidder fail to complete the delivery of software development modules, installation and testing of the ordered equipment/component along with imparting of training by the date/dates specified in the RFP or any extended period, ERNET India may at its discretion withhold any payment, as liquidated damages (and not by way of penalty) at the rate of 2% of the PO value per week or a part of a week subject to a maximum of 10%. The amount towards Liquidated Damage would be recovered from the performance security or the amounts due to bidder. In case the cumulative delay is beyond 7 weeks during the implementation period, ERNET India reserves the right to cancel the purchase order and forfeit all due payments including forfeiture of Security Deposit/performance BG, besides initiating legal action as per rules/laws and/or debarring / blacklisting the bidder concerned for at least three years, for further dealings with ERNET India.
- iv. Non submission of performance security as per above schedule may lead to cancellation of work order. Also any payment due on ERNET INDIA w.r.t work done by the bidder till such date will be forfeited.
- v. The methodology of installation work, to be adopted, has to ensure minimum damage to the existing finish and no loss to the aesthetic beauty of the sites. Any damage to the existing structures due to the execution of work order, under any circumstance shall be made good by the bidder.
- vi. All materials submitted by the bidder(s) through this EoI/RFP will become the property of ERNET India/its customers.
- vii. All authorizations & undertaking from the OEM should be in original ink signed and stamped.
- viii. All the other documentary proofs should be self-attested by authorized person.
- ix. During the process of evaluation, ERNET India reserves the right to seek clarifications from bidders, wherever needed.
- x. ERNET may give partial or full work. ERNET may also ask to develop modules other than security. The same may inform time to time as per requirement.
- xi. The detailed payment terms will be illustrated in the RFP floated amongst the shortlisted bidders through this EOI process.

11. DOMESTIC MANUFACTURER CLAUSE

a) Preference will be given to domestically manufacture electronic goods in procurement. Guidelines as per Govt. Notification No. 8(78)/2010-IPHW dated 10-2-2012, and

subsequent amendments/clarifications will be followed for implementation. Bidders must submit an undertaking on notarized Rs. 100/- stamp paper as per Annexure-VI: PMA AFFIDAVIT mentioning the percentage of domestic value addition (in terms of BOM) for each quoted item/product under a schedule to avail any applicable preference at the time of placing of purchase orders.

- b) Bidders who do not provide the undertaking shall not be considered for receiving this preference. Also the above preference will be subject to satisfying technical specifications / technically qualified bid and matching the L1 price by the bidder(s).
- c) Bidders quoting false/ incomplete information will be rejected at any stage (even after awarding of contract) and their any due payments and/ or Security Deposits will be forfeiting. ERNET may also debar and blacklist the bidder(s) concerned for at least three years, for further dealings with ERNET India and further initiate legal action as per rules/laws applicable.

12. DAMAGE TO PERSON AND PROPERTY

The bidder shall (except, if and so far as this agreement provides otherwise), indemnify and keep indemnified the ERNET India & its all customers against all losses and claims for injuries or damage to any person or property arising out of or in consequence of the construction and maintenance of the works by them and against all claims demands, proceedings, damages, loss charges and excesses whatsoever in respect of or in relation thereof.

13. INDEMNITY

The successful bidder(s) shall indemnify the ERNET India/End-user departments against all third party claims of infringement of patent, trademark/copyright or industrial design rights arising from the use of the supplied items and related services or any part thereof. ERNET India/End-user department stand indemnified from any claims that the bidder's manpower may opt to have towards the discharge of their duties in the fulfilment of the purchase orders. ERNET India/End-user department also stand indemnified from any compensation arising out of accidental loss of life or injury sustained by the bidder's manpower while discharging their duty towards fulfilment of the rate contract and purchase orders. The bidder shall solely responsible for any damage, loss or injury which may occur to any property or to any person by or arising out the execution of the works or temporary works or in carrying out of the contract otherwise than due to the matters referred to in this agreement hereinbefore. The bidder would ensure for observance of all labour and other laws applicable in the matter and shall indemnify and keep indemnified the ERNET/its customers against the effect of no observance of any such laws.

14. FORCE MAJEURE

If at any time, during the period of contract, the performance in whole or in part by either party of any obligation under the project is prevented or delayed by reasons of any war, hostility, acts of public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics quarantine restrictions, strikes, lockouts or acts of God (hereinafter referred to as "events"), provided notice of happenings of any such event is duly endorsed by the appropriate authorities/chamber of commerce in the country of the party giving notice, is given by party seeking concession to the other as soon as practicable, but within 21 days from the date of occurrence and termination

thereof and satisfies the party adequately of the measures taken by it, neither party shall, by reason of such event, be entitled to terminate the contract, nor shall either party have any claim for damages against the other in respect of such non-performance or delay in performance, and deliveries under the contract shall be resumed as soon as practicable after such event has come to an end or ceased to exist and the decision of the purchaser as to whether the deliveries have so resumed or not, shall be final and conclusive, provided further, that if the performance in whole or in part or any obligation under the contract is prevented or delayed by reason of any such event for a period exceeding 60 days, the purchaser may at his option, terminate the contract.

15. ARBITRATION

- i. Any dispute or difference whatsoever arising between the parties out of or relating to the construction, meaning, scope, operation or effect of this contract or the validity or the breach thereof which cannot be amicably resolved between the parties; within 90 days from the date of raising of dispute by any of the party; shall be settled by arbitration in accordance with the Rules of Domestic Commercial Arbitration of the Indian Council of Arbitration and the award made in pursuance thereof shall be binding on the parties.
- ii. The venue of Arbitration shall be Delhi.
- iii. The law governing arbitration shall be Arbitration and conciliation Act, 1996.
- iv. The language of the arbitration shall be English.
- v. Pending reference to arbitration, the parties shall make all endeavours to complete the work in all respect. Disputes, if any, will finally be settled in the arbitration.

16. APPLICABLE LAW

- i. The bidder shall be governed by the laws and procedures established by Govt. of India, within the framework of applicable legislation and enactment made from time to time concerning such commercial dealings/processing.
- ii. All disputes in this connection shall be settled in Delhi jurisdiction only.
- iii. ERNET India reserves the right to cancel this tender or modify the requirement without assigning any reasons. ERNET India will not be under obligation to give clarifications for doing the aforementioned.
