ERNET India, an autonomous scientific society under the Ministry of Electronics & Information Technology, has been set up with the main objectives of developing, setting up and operating a nationwide state-of-art Computer development, training and standardization in the area of computer networking and information technology and to develop options for consideration of the Government for development of information infrastructure and computer networking in the country. The headquarter of the Society is based in Delhi and regional offices at Bangalore & Chennai.

2. Applications are invited from suitable personnel for filling up following posts.
3. The mode of Recruitment, the eligibility criteria and place of posting for the post of each post to be filled is as under:-

**Eligibility Criteria**

**(i) Educational Qualification & Age for Direct Recruitment:**

B.E /B.Tech/M.Sc. or equivalent in the related field (\*) with minimum 60% marks from a recognized University Institution.

Experience – 9 Years in the relevant field(\*)

OR

M.E./M.Tech in related field (\*) with minimum 60% marks from a recognized University/Institution.

Experience – 8 Years in relevant field(\*)

OR

Ph.D. in the related field(\*) from a recognized University/Institution.

Experience – 5 years in the relevant field(\*)

(\*) Computer Communication & networking, Data Communication, Internet & Web technology, VSAT Communication

There is no vacancy reserved for PWD category other than PWD (LV-Low vision). However the post is identified for the Physical Handicapped Person under the category of one Arm (OA), One Leg (OL), Both Leg (OL), and Hearing Handicapped (HH).

In case no suitable candidate found in PWD (LV) category then the position will be filled amongst categories as earmarked above.

**Age :** Not exceeding 40 Years (Relaxation as per GoI norms).

**Definition of Person with Disabilities:**

Under Section 33 of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995, only such persons would be eligible for reservation who suffer from not less than 40% of relevant disability and are certified by a Medical Board constituted by the Central/State Government.

**Note :** Candidates belonging to 'Non Creamy Layer' are eligible to apply under OBC Category. The OBC candidates who belong to 'Creamy Layer' are not entitled to apply under OBC Category. Candidates may please note that the non-creamy layer certificate issued before 1<sup>st</sup> September, 2017, will be treated as outdated and such applications will be liable to be rejected.

**(ii) For Transfer (absorption)/ Deputation:**

In case of transfer (absorption)/deputation, officers of the Central/State Governments/ PSUs/ Autonomous bodies:-

Diploma in Engineering/B.Sc. in the related field (\*) with minimum 60% marks or possessing DOEACC 'A' level certificate.

Experience – 5 years in the relevant filed (\*)

(\*) Computer Communication & networking, Data Communication, Internet & Web Technology, VSAT Communication.

Age : Not exceeding 30 years (Relaxation as per GoI Rules)

The Post of Technical Assistant is identified of the Physical Handicapped Person under the category of One Arm (OA), One Leg (OL), Hearing Handicapped (HH), Low Vision (LV).

#### **(ii) For Transfer (absorption)/Deputation:-**

In Case of Transfer (absorption)/deputation, officers of the Central/State Governments/PSUs/ Autonomous bodies:-

Having 4 years experience in the scale of pay Rs. 5200-20,200 (PB 1) Grade Pay Rs. 2400/- (Pre-Revised) or pay matrix level 4 Rs. 25000-81100/- in the relevant filed (\*)

(\*) Computer Communication & networking, Data Communication, Internet & Web Technology, VSAT Communication.

4. The Person selected for the above posts will also be eligible for medical facilities, reimbursement of tuition fee, etc as per the Bye Laws of ERNET India.

5. Interested candidates possessing the above qualifications and experience may apply in the prescribed format **(Annexure-I)**. The applications must be supported by self attested copies of certificates relating to educational qualifications, date of birth, experience, category (SC/ST/OBC) & one recent passport size photograph, indicating the name of the post applied for on the envelope. Applications along with copies of required documents must reach to the Registrar & Director (P&A), ERNET India, Block-I A-Wing, 5<sup>th</sup> Floor, DMRC IT Park, Shastri Park, Delhi – 110053 **within 30 days of publication of employment news advertisement. Incomplete applications will be rejected and no correspondence in this regard will be entertained.**

6. (i) Candidates applying for the post on direct recruitment basis must enclose Pay Order/Demand Draft of Rs. 500/- **in favor of, "ERNET India", New Delhi** along with the application. However, SC/ST/women candidates/Persons with Disability and Ex Servicemen are exempted from payment of fee.


(ii) The candidates, who are applying on deputation/Transfer basis are also to submit attested copies of ACR for the last five year.

(iii) For appointment on "Deputation Basis" (foreign service), the deputation would be governed by the terms and conditions contained in Department of Personnel and Training guidelines as amended from time to time.

7. The candidate must ensure that he/she fulfils the educational qualification & experience criteria as prescribed on the last date of submission of application i.e **07.01.2019.**

8. The candidates who are already working in Central Govt./State Govt./PSUs/Autonomous Bodies must submit their application through "Proper Channel" certifying that no Vigilance/Disciplinary case is pending/contemplated. Applications received after the due date, and without vigilance clearance will not be entertained. The candidates, who are already in service can send "Advance Copy" to avoid delay in submission of application. The Officer once selected shall not be allowed to withdraw his/her candidature at a later date.

- i. Govt. Orders regarding age relaxations to various categories of candidates will be applicable.
- ii. Only short-listed candidates will be called for test/interview. Mere fulfilling of requirements as laid down in the advertisement does not qualify a candidate to be called for test/interview.
- iii. For meeting the eligibility criteria the relevant experience will be counted from the date of passing the essential qualification required for the post to be filled up.
